#### Qualitative analysis of Criterion 1

Nashik Shikshan Prasarak Mandal's Nashik Arts and Commerce College has started functioning sincer 2012-13 in the tribal majority Taluk of Igatpuri in the district of Nasik, Maharashtra. The aim is to spread higher education and equipping the students with modern technology. This co-educational college is affiliated to the Savitribai Phule Pune University and works in self-financing mode; it currently offers five Undergraduate Programmes in Choice Based Credit System. The institution is owned and managed by the Nashik Shikshan Prasarak Mandal.

The college has adopted systematic mechanism to organize the teaching-learning process and has undertaken curriculum delivery through term-wise teaching. The academic calendar includes all programs and is prepared giving priority to the student centric activities. The faculty uses various student centric activities related to academics. Co-curricular activities are organised for students to learn by doing. Co-curricular activities like competitions- Elocution, Poster Presentation, Paper Presentation, Group Discussion, Book Review, etc. are conducted. The other learning activities include group discussion, group tasks, paper presentations, power point presentations, seminars. Academic Diary detailing the syllabus covered, reading material and number of delivered lectures is maintained by individual teacher.

Teachers also prepare term-wise teaching plan in the academic session. Each department prepares its annual plan for the curricular, co-curricular and extra-curricular activities. The annual calendar committee prepares the academic calendar taking the individual department's plans into consideration; the plan is also in the staff meeting. Value orientation to the learning process is added through prayers, awareness campaigns and projects.

The teachers are encouraged to use ICT tools in the teaching learning process through training sessions. Similarly the students are given task of doing presentation on PPTs. Special sessions are arranged to introduce the use of internet and computer to the students.

Invited lectures by experts are organised to acquaint students with recent trends in their subjects. The college has introduced courses like Soft Skills, Certificate Course in GST, Business Communication in English, and Banking. Activities on gender related issues, personality development human values and professional ethics are also organized. The college has taken feedback from students, teachers, alumni and parents. But the system

#### Qualitative analysis of Criterion 2

Though lecture method is the predominant mode of teaching, the college attempts to adopt the student centric and experiential learning to an extent. Activities like Field Visit, Industrial Visit, Demonstration, conducting experiments, Mock Parliament, Advertisement, Dialogue Writing, Workshops, etc. are organized. Participative learning is accomplished through Seminars, Group Discussions, Publication of Wall Paper etc.

The college follows the admission policy as stipulated by the affiliating University. Fee structure is in the prospectus. The college ensures equity of access by reserving seats as per the government regulations. The academic process caters to diverse range of learners. ICT integration into the teaching-learning process is limited.

Majority of the teaching staff are SET/NET qualified and pursuing Ph. D. The student- teacher ratio is rather reasonable. Internal assessment of students is done through assignments, tests and preparatory tests.

Class teachers (Mentors) monitor the progress of students and are counselled for their academic improvements and personal problems. The result analysis is carried out and remedial measures are adopted. At the commencement of the course the students are given subject orientation.

Examination dates are decided by the affiliating University and intimated to the colleges, and the same is incorporated in the academic calendar. The schedule of the examination is conveyed to the students and teachers through timely issued notices which are also displayed on the notice boards as well as on the college website. Students' grievance regarding examination, if any, are taken care of by the examination committee within stipulated time.

Programme Outcomes and Course Outcomes for all Programmes are coined by the University and displayed on the institutional website. Further the methods of measuring them needs to be devised more scientifically and

#### Qualitative analysis of Criterion 3

The college encourages research culture; it can be seen with three of faculty perusing their Ph D. The ecosystem for research and innovation is being put in place with number of research publications in recognized journals. The college allows faculty to attend and organize seminars/ workshop or visit useful institutions. Duty leave is sanctioned in such deserving cases and some financial assistance is also extend to them. The college has established Incubation Center and IPR cell. But their effective functioning in the respective fields leading to the desired out is to be materialized.

During the assessment period the college has organized a State level conference on Women Empowerment and eminent scholars have visited the institution. The NSS unit of the college has adopted a village for its overall development. Outreach programs by the N.S.S unit in the field of Water Conservation are conducted in the adopted villages. The college has a few functional MoUs with various institutes and organizations.

At the same time there is the need for more focused and proactive efforts for sourcing grants for research projects from agencies and increasing the number of result oriented workshops and seminars in the field of research methodology, IPR and entrepreneurship.

The college has registered its name in Limca Book of Record for "Suryanamskar Ek Avishkar" and also World Records India for participating in "Longest Suryanamskar to Yogamarathon (multiple venue)

#### Qualitative analysis of Criterion 4.

The college has six classrooms, one ICT enabled Seminar Hall, a Sports Room and four departmental cubicles for the teaching staff. The college also has limited facilities for sports, games and cultural activities. Parking facility for the students and staff are provided. Provisions are also made in the budget for maintenance of physical facilities and academic support facilities. The library has about 1100 books and some journals. The college has a management software through which library automation process also is initiated. Though small in amount, annual budgetary provision is made for the purchase of books and journals to the library. Average number of teachers and students using library is around 20 per day. There is a student support centre with photocopier and internet facility. College has 15 computers and has signed an MOU with nearby M G. High School, Igatpuri for using their computer laboratory with 10 computers. The present Internet bandwidth in the college is 5 to 20 MBPS and needs augmentation to much higher capacity. The non-teaching staff is given responsibility of maintaining the physical facilities. An annual maintenance contract is signed by the institution for the same.

el scholarships and freeships etc. in the prospectus as well as on website. Considerable percentage of rudents avail scholarships. The college organizes workshops and lectures on career guidance. Personal Counseling is provided to the students.

The college has a mechanism for handling student grievances, sexual harassment and anti-ragging. Awareness is created on these issues through the workshops and guest lectures. Students participation is ensured in various college level committees. Many students of the institution have progressed to Higher Education. Good number of sports and cultural activities & competitions are organized on the campus. But there is scope for improvement in these areas. Students participation in sports and cultural events hosted by other good institutions is encouraged.

At the same time the fact that the number of students qualifying state / national level competitive examinations is negligible which needs to be looked into by the institution. Though not registered, an alumni association, as noticed during the interaction, is functional. Alumni meet a few times every year. Their feedback regarding campus infrastructure facilities, campus environment is collected.

CDC and IQAC monitors the college administration in routine matters. The college has created the system of collective decision making through formation of committees in which stakeholders participate. IQAC suggests programmes and activities for the approval of CDC. HODs and committee coordinators help the Principal in implementation of the decisions.

of the faculty members and teacher evaluation by students are in place. There are a few minimal welfare activities for teaching and non-teaching staff. Teachers are given financial support to attend conferences/workshops. The non-teaching staff are encouraged to attend professional development programs and administrative trainings.

Internal audit and external audit are mandatorily conducted. Under various schemes of Savitribai Phule Pune University, the college had received small financial assistances to organize various workshops and competitions.

The IQAC has been helping in carrying the Performance Appraisal System for the staff members. Based on its the system of awarding Letter of Appreciation to the teaching and non-teaching staff for their achievements has been started. Similarly IQAC recommends arrangements for the students to give their feedback/ suggestions or complaints anonymously through complain/suggestion box. This box is opened occasionally and the feedback/ suggestions or complaint is considered seriously for corrective actions.

The administrative authorities of the college needs to chalk out well thought out long term perspective plan for the future development of the institution.

### Qualitative analysis of Criterion 7

The college is situated in a secure residential area of Igatpuri. It caters to the need for education, training for empowerment skills of the villagers. It helps in spreading awareness among girls who leave the college and get married early.

The institution has installed CCTV cameras in the premises for security and has dress code and Identity Cards for the students. Committees like Anti Ragging Committee, Women's Grievance Redressal Cell, Discipline Committee are there. University Representative and Class Representatives are elected. Guest Lectures and career Guidance are organised. Various Women Empowerment Programmes like Nirbhay Kanya Abhiyan and Karate Training are organized. Awareness programmes on alternate sources of energy and energy



aservation are conducted.

To create self-employability skills, Mushroom cultivation technology is taught to them. For imparting the training the college has signed an MoU with Mann Deshi Foundation. The college also organizes NSS Camp through which the rural women get a chance to participate in the mushroom cultivation training programBesides the women empowerment programmes, the college also conducts Yoga and awareness programmes for Mental Health. The college has signed an MOU with Vipassana Research Centre at Igatpuri.

Though some initiatives for water conservation, green campus, waste management etc. are there, more efforts are needed. Academic Audits and Energy audits are also to be more effective.

The college commemorates various days like International Yoga day, Independence day, Teachers day, Gandhi Jayanthi, Republic day and many more. One of the best practices is earn while learn for the students by the college. The students get paid on hourly basis for the work in the college office and library.

Various stakeholders of the institution need to work together and identify suitable avenues to work on the best practices and think of taking the college further in progress.
